Minutes for the Meeting: November 29, 2015

Location: Conference call

- I. Call to order by Eric Yokoyama at 10:00 A.M. Also in attendance: Stacey Kosaka, Lynn Matsubara, Jane Taguchi and Lynne Tomita.
- II. Minutes were approved with corrections. Lynn requested that Lynne email all minutes from prior meetings, so that the website will be updated to show the minutes. Lynne to let Stacey know which minutes that are missing.
- III. Treasurer's Report-Jane reported that the bank statement had a balance of \$9,438.40. The breakdown is Storm ball offers: \$600.00, \$1425.00 memberships plus an additional \$30.00. Jane did not have time to do a financial statement as her father is in the hospital.
- IV. Membership Report –
 - a. Stacey reported that membership is at 290 as of today, and we ended the fiscal year with 488 members. Stacey has not heard from Linda K. in regards to her membership application. The cards will be blue this year.

V. Tournament Committee Business:

Stacey reported that Eric, the General Manager at Beverly Bowl was let go a couple of weeks ago. Currently, only the TOC is booked at Beverly Bowl.

- a. SFV Nisei-Eric requested 2 Storm ball offers for the tournament, and 1 offer for the league. This will give the tournament 4 balls plus 1 ball from Cook's for a total of 5.
- b. Tozai-Lynne reported that there were 50 Senior Singles, 24 Mixed Teams, 26 Open Teams and a total of 63 Mixed Doubles. There are some glitches to work out as far as committee members duties, but overall, a step forward in progress. Stacey reported that there were some questions as to why the squads ran late. Lynne reported the only squad that ran 15 minutes late was the Open Team and the last Mixed Doubles Event was 10 minutes late. These were due to miscommunications with personnel in the squad room and are being resolved. All the other squads started either on time or max five minutes.
- c. Las Vegas-set at Suncoast for June 25th and June 26th in 2016.
- d. Holiday Craft Fair-The lower end of the center will be used for the Craft Fair. Jane asked about getting 2 posters the size of 2 X 24 X 36. Lynn Matsubara said that she can get them. Jane reported that she has two easels that can be used for displays. Jane has drafts for more posters and Lynn said that she can print those also. Jane reported that there are a limited amount of long tables, which she let some of the vendors know, so some of them are bringing their own. Would it be okay for the tournament committee to use round tables instead? Eric replied that it would be ok for the use of the round tables. Lynn reported that she will be needing to get 2 gift baskets around the \$30.00 range to do the give-away.
