Minutes for the Meeting: June 6, 2015

- I. Call to order by Eric Yokoyama at 1:20 P.M. Also in attendance: Stacey Kosaka, Lynn Matsubara, Jane Taguchi and Lynne Tomita.
- II. Minutes were approved with corrections.
- III. Treasurer's Report-Jane presented the Treasurer's Report for all to peruse. See attachment.
- IV. Membership Report –
 - a. Stacey reported that membership is at 456 as of today. Stacey reported that the secretaries have been slow on the submission of the ending league sheets. .
- V. Tournament Committee Business:
 - a. SFV Nisei-Eric reported that the league is moving to Harley's Simi Valley with the closing of Mission Hills Bowl. Further discussion about the SFV Tournament in the New Business section.

 - c. TOC- Linbrook Bowl will be hosting the event on 7/12/15 because of the Bowl-Mor liability insurance clause requiring a 1 million \$ coverage per incident. Stacey informed us that the GM for Beverly Bowl has had discussions with the upper management regarding this, and will keep us informed about new developments.
 - d. Singles-Linbrook Bowl is hosting the event on 8/4/15. Please start thinking about the giveaways for the new year. Could it be a pocket knife (\$2.00 or less). Lynn suggested looking at 4imprint.com for ideas. We should look at items that are about \$1.00 or less, each.
 - e. Holiday & Craft Fair-Will be held at Palos Verdes Bowl this year. Jane to provide more details as they readily become available.
- VI. Old Business:
 - a. Non-Japanese-qualifying: A discussion was held in regards about the Non-Japanese qualifying, and the use of alternates. After the two years of bowling at least 67% of the total number games of the season, one must still bowl at least 50% of the current season number of games (alternates). Reestablishment of membership also requires 50% of the current season's league games as a regular member.



VII. New Business:

- a. SFV Tournament will be held at Harley's Simi Valley Bowl. Eric reported that it is a 40 lane center and the tournament will be 1 week-end. Eric stated that he is looking at the 3rd. week-end in January, 2016. The events will be on a first come first serve basis. The events are Mixed Team, Men's Team, Mixed Doubles and Senior Singles.
