## SAN FERNANDO VALLEY NISEI BOWLING TOURNAMENT RULES

1. This tournament shall be governed by the rules and regulations of USBC and the Southern California Nikkei Bowling Association (SCNBA). All members must be in good standing with the USBC and must hold a valid USBC adult membership card. Non-USBC members can purchase an associate membership card for \$25.
2. Bowlers must be certified USBC members in order to receive USBC awards. Bowlers must be current members of the SCNBA in order to participate. All entries will be verified. On-site membership cards will only be sold to those that are eligible under option A (see below).
3. This tournament shall take place on January 19-20, 2019 at Harley's Valley Bowl, 5255 Cochran St, Simi Valley, (805) 584-2695. Full payment and entries must be postmarked by January 8, 2019 per rule 310a-2.
4. **Entry Fees:** \$30 per person per event (prize: \$17.25 + lineage: \$9.75 + expenses: \$3). Entry fees must accompany entry forms. Incomplete entries or entries without total fees will be returned. Mail entries to: SCNBA SFV Nisei, PO Box 1144, Montebello, CA 90640; E-mail: info@scnba.com.
5. **Mixed Team and Open Team will be limited to the first 38 teams entered; \*Mixed Doubles will be limited to the first 57 teams per squad; Singles will be limited to the first 114 bowlers. \*Bowlers may bowl multiple times but cash with the same partner only once.**
6. As per USBC rule 319a, all averages will be verified and guaranteed by the Southern California Nikkei Bowling Association. USBC rule 319a-2, rule 319a-3 and rule 319e are waived. **Handicap of 90% of 220 will be determined from the following parameters:**
  - a. **Highest USBC CERTIFIED WINTER 2016-17 or 2017-18 average, 21 games or more; If none,**
  - b. **Highest USBC certified current average of 21 games or more as of January 1, 2019 (League sheet must be provided); If none,**
  - c. **Highest USBC certified 2018 summer average of 21 games or more (League sheet must be provided);**
  - d. **If none of the above, scratch 220.**

Minimum averages: 150 (men) and 135 (women). All bowlers are responsible for verifying their own average. If the submitted average is lower than the verified average and results in more handicap, the bowler's score is disqualified. If the submitted average is higher than the verified average, prize winnings will be based on the submitted average. **All averages established on a Sport or Challenge condition must be adjusted utilizing the USBC Sport Average Adjustment Scale found on BOWL.com. The adjusted average must be used if it is the highest average.**
7. A bowler whose average has been re-adjusted by any tournament committee must report the re-adjusted average when submitting an entry. The re-adjusted average (or highest average) will be used for twenty-four (24) months from the date of notification. Not reporting adjusted averages will result in disqualification. Rule 319c will apply.
8. Prize money will be returned 100%. At least 1:8 will receive prize money in each event. The two mixed doubles squads scores will be combined to determine overall winners. Before any prize distribution, tournament officials have the right to verify averages with city associations. Ties for first place will be declared co-champions and prize money will be equally divided.
9. All bowlers must report thirty (30) minutes before their scheduled squad begins.
10. If an entrant cannot bowl, a substitute can be named thirty (30) minutes prior to squad time. No entry fees will be returned. Late arrivals will receive zero (0) for frames missed and must bowl from the frame in progress.
11. The Tournament committee is required by the Internal Revenue to file a 1099 for any prize and/or award payment of six hundred (\$600) dollars or more in a calendar year.
12. No more than one (1) lane courtesy will be allowed.
13. A bowler who has qualified for a total prize of \$300 or more in any Nikkei tournament within the last twelve (12) month period must report the actual score, position, and amount won to the Tournament Committee at the time of entry in a handicap or classified tournament for possible re-rate. Such re-adjusting must be done seven (7) days before the entrant bowls and if not accepted, the entry fee will be refunded. Failure to report earnings will be cause to forfeit tournament entry fee and prize winnings.
14. Tournament Management will disqualify participants for the following reasons: falsifying scores; conduct not becoming a USBC bowler as determined by Tournament Management; changing from right hand to left hand or visa-versa during the tournament; and delaying tournament play. All decisions are final unless an appeal is made to USBC per Rule 329.
15. Effective September 1, 1996, any member of any professional organization will bowl scratch in all SCNBA events. Upon releasing the card, there will be a period of twenty-four (24) months following that he/she will continue to bowl scratch.
16. Protests must be made in writing to the Tournament Management before the tournament prizes are paid. Protests must specify the rule violated. Disputes and complaints must be filed by participants only. Decisions by Tournament Management will be final unless an appeal is made in accordance with Rule 329.

**\*\*SCNBA ELIGIBILITY FOR NON-JAPANESE (CARDS CAN BE PURCHASED ON-SITE FOR "A" ELIGIBILITY PARTICIPANTS ONLY)**

### Membership eligibility shall be governed as:

- a) Those persons with at least 25% Japanese ancestry. (If current last name is not Japanese, the Japanese surname of parent/grandparent must be provided).
- b) Those persons of non-Japanese ancestry currently married to an individual with at least 25% Japanese ancestry.
- c) Those persons of non-Japanese ancestry with a parent\* that is at least 25% Japanese ancestry. \*Child must be natural, legally adopted or step.
- d) Those persons of non-Japanese ancestry who meet the following requirements:
  1. Must have bowled a minimum of 67% of the regular league games in a qualified "Nikkei" bowling league for two (2) consecutive winter seasons immediately preceding application for membership, and
  2. Must be currently bowling in a Nikkei bowling league as a regular league member with 21 games or more.
    - a. Eligibility is not effective until 50% of the current winter total league games as a regular league member are met, at which time they can apply for membership the following year.
    - b. Membership re-establishment can be obtained once the bowler has at least 50% of the current season's games as a regular league member
- e) Non-Japanese card-holders whose Japanese spouse is deceased remains eligible until remarried to a non-Japanese.

*The term "NIKKEI" bowling league refers to a USBC certified league having not less than 67% of its league members including substitutes being at least 25% Japanese family ancestry and non-Japanese actively belonging to the SCNBA (all bowlers minimum 21 games). If a league falls below 67% at the end of the winter season, the non-Japanese bowlers shall not be eligible for membership for the upcoming winter season.*
